 - (ii) 50% of the total seats of the courses have been enmarked as Govt quota and) 50% of the total seats of the courses have been enmarked as KCHF quota for BSc MLT, BPT, Bsc. Med. Micro Biology & Bsc. Medical Bio Chemistry Course.
