## PROSPECTUS 2024-25

### 1. INTRODUCTION

The Co-operative Institute of Health Sciences have been established Since 1999 with the aim of providing quality education and training in the various disciplines of Health Sciences. The Institution have been developed without any subsidy as a fully self-financed Centre of higher education. Hence the finance for the infrastructure and expenses for the conduct of courses are to be met from the fees, service charges collected from the students.

CIHS has conceptualized & Implemented a group of professional up-gradation programmes meant to equip the healthcare professional with the appropriate tools in order to survive this age of fierce competition and specialisation. The CIHS encourages a symbiosis of thought, word & action of all such professionals who would address the all important issue of health in its totality. Though its unique, innovative, career oriented programmes, CIHS to raise a cadre of professionals who would ensure delivery of optimum health care services. ### 2. COURSE OF STUDY

The Institute offers the following courses of study for the academic year 2024-25. Name of the courses, duration, eligibility for admission and the details of fee structure are as follows:-See Table-I and item 4 fees. Fees will be changed as per G.O. 2024-25 admission notification

Note:- Courses are affiliated under Kerala University of Health Sciences, Thrissur and conducted by Kerala Co-operative Hospital Federation Ltd.

### 3. ADMISSION

- (i). Admission to the course will be on the basis of merit. Candidates who have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examination recognized by any of the universities in the state of Kerala with 50% marks in physics, chemistry, and biology put together are eligible for admission.
- (ii) 50% of the total seats of the courses have been enmarked as Govt quota and) 50% of the total seats of the courses have been enmarked as KCHF quota for BSc MLT & BPT Course.
- (iii) Eligibility certificate: Candidates who have passed their qualifying examination from outside the state of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from Kerala University of Health Sciences, Thrissur. This should be furnished at the time of interview.
- (iv) Applicants should have completed 17 years of age on 31st December 2023. No relaxation of the minimum age will be allowed.
- (v) The students shall pay the fees for first year of the course at the time of admission which will not be refunded.

### 4. FEES

- 1) Remitted fees of First year shall only be refunded if the student discontinue the course before the last date of closing of admission stipulated by the competent authorities.
- 2) Examination fee is to be remitted as per University Notification from time to time.
- 3) The fee is fixed by the management as per relevant court verdict and Govt. orders Time to Time
- 4) Fee is liable to change as per Govt. Direction.

## **SELECTION**

1. Selection of the candidate will be done based on the rank list which is prepared by calculating the total marks of Physics, Chemistry, Biology acquired in the second year only.

- If any candidate who is provisionally selected, fails to report to the Officer concerned, on or before the specified time and date, his/her selection stands automatically cancelled without any further information.
